## ***CEV Activities***

### **CEV General Assembly in Luxembourg attended by more than 150 participants**



The second 2008 CEV General Assembly (GA) took place in Luxembourg from 6 to 8 November 2008 and focused on "Volunteering and Intercultural Dialogue". During the opening panel, the invited speakers, among whom were Suzanne Monkasa, president of the Council of African Communities in Europe and in Belgium, and Jacques Küntziger, Counsellor on volunteering within the Ministry of Family and Integration in Luxembourg explored and defined the meaning of Intercultural dialogue, followed by the interactive Dialogue Café discussion among the participants on the issue of volunteering and intercultural dialogue. In the afternoon session, some CEV members and other partner organisations presented good practices on volunteering and intercultural dialogue. The workshops dealt with themes such as anti-racism tools in sport; integration of refugees in the hosting communities; exchange of senior volunteers across Europe as a mean of intercultural dialogue; festival of migrants. At the statutory business meeting, the CEV members adopted a new membership fee regime, introducing new scales of payments. These new fees will ensure a bigger independence of CEV from European Commission funding. The new fees are published on the CEV [website](#)<sup>1</sup>.

## CEV invited by Belgian High Council for Volunteering

CEV director Markus Held was invited to speak on 9 October 08 to the High Council of Volunteering in Belgium, an institution created to advise the Belgian government in volunteering issues. The CEV member organisations play a major role in this Council and Eva Hambach, member of the CEV Board, is its Vice-President. This meeting was aimed at preparing grounds for the Belgian Presidency of the EU in 2010 and debating items we want the Presidency to move forward. And secondly, the High Council voiced its support for advocating with the Belgian government an adoption of the European Year of Volunteering 2011.

## First Network Meeting of the VALUE Grundtvig Network

The Value [Volunteering and Lifelong Learning in Universities in Europe] Network is a [Grundtvig Thematic Network](#)<sup>4</sup> that brings together Universities, and more specifically Lifelong Learning Centres within Universities and volunteer organisations. The first network meeting took place on the 14<sup>th</sup> of October in Manchester and it was meant to give a first insight into the practicalities of the project and the obligations that each partner has. CEV member organisations are well represented in this network: CSV.net (Italy); Provobis (Romania); C.A.R.D.O (Slovakia), are all partners of the project, while Volunteering England/Institute for Volunteering Research (UK) is one of the coordination organisation. More details on this network will be available soon at CEV website and a new VALUE website is about to be launched.

## EYV 2011 Alliance meets EU Commissioner Špidla



In the framework of the campaign for the European Year of Volunteering 2011, CEV and delegates from the Social Platform, solidar, the Scouts and the Youth Forum have been invited to meet Commissioner Špidla on 11 November 08. He pledge his full support to the campaign underlining the crucial value of volunteering in social policies, for which he is responsible. His Directorate General for Employment and Social Affairs is planning to organize the European Years 2010 (Combating Poverty and Social Exclusion) and have plans for 2012 (Active Ageing and Intergenerational Solidarity) – 2010 would fit neatly into these plans. He promised to raise the issue with his colleague Commissioner Figel', who is responsible for the volunteering portfolio – and whose invitation for a meeting we are still waiting for.

## European Year of Volunteering 2011 Campaign – crucial phase!

As reported to our members before, we have entered the crucial phase of the European Year campaign. In order to make the Commission move on the issue, support of governments is

indispensable. The ministers of Education, Culture and Youth will meet on the 20 and 21 November and can there issue a common call on the European Commission to declare the Year. The French Presidency has confirmed their official support for the Year 2011 that shall put the European Year of Volunteering 2011 on the informal agenda of the meeting. A very good opportunity for the representatives of your governments to speak out in favour of the Year and invite Commissioner Figel' to act swiftly now and launch the proposal still under his mandate. We would like to invite you to write to the delegate representing your country immediately – for the sample letter you might use refer to the emails that CEV secretariat has circulated among the members on the issue.

## **CEV at Europe for citizens Forum 2008**

The 2008 Europe for Citizens Forum entitled “Participation for making a difference” took place on 13 and 14 November 2008 in Brussels. The principal goal was to examine how active participation can make a difference to the EU and general constructing and development of Europe. The Forum was inaugurated by top-level EU representatives, followed by the [Golden Stars award ceremony](#)<sup>5</sup>, which rewarded ten outstanding citizen-centred projects. CEV was represented at the Forum by Markus Held who was appointed rapporteur for a workshop on “European elections – what role for civil society?”. ## **2<sup>nd</sup> Partners' meeting of the *Think Future, Volunteer Together!* Project in Bratislava**



Kamila Czerwińska, CEV Project and Policy Officer participated in the 2<sup>nd</sup> partners meeting of the project *Think Future, Volunteer Together*. This meeting was hosted by C.A.R.D.O. in Bratislava (SK) on 13-14<sup>th</sup> November 2008. This European project, funded by the European Commission, is managed by SPES and involves 4 other CEV members - C.A.R.D.O. (SK), Slovenska Filantropija (SLO), ÖKA (HU) and Pro Vobis (RO) in 2 weeks long senior volunteers' exchanges. CEV acts as EU policy advisor partner. During the meeting partners discussed their experiences on the practical challenges related to organisation of exchanges after 1 year of the project. On the second day, partners participated in a public presentation of the project, where Slovak volunteers talked about their travels to Italy, Slovenia and Hungary. ## **CEV responds on exploratory opinion on EESC "European Civic Service"**

The European Economic and Social Committee EESC has been asked by the current French Presidency of the EU to explore the feasibility of a European Civic Service similar to civic service schemes existing in Germany, Italy and other countries. CEV has been invited to a stakeholder meeting on 5 November to comment on the initiative. We have raised our concerns about the process chosen by the French Presidency: There has been no prior debate nor a needs assessment with volunteer organisations on a European Civic Service and we urged the EESC to recommend a fully-fleshed consultation procedure on this initiative in order to assess whether and how such a scheme should be implemented. We have offered our support for the next steps in this work – but insist that there be a meaningful civil dialogue – and agreement on the underlying concepts: Volunteering should not be mixed up with schemes such as alternative “civic” services that can be as replacement of (obligatory) military schemes.

### First Volunteer of the Year Award launched in Malta



[Solidarity Overseas Services Malta](#)<sup>11</sup> (SOS Malta) launched the SOS Malta Award for Volunteering. The aim was to recognise the precious work of those who volunteer with not-for-profit organisations, charities and NGOs.

The winner, Astrid Vella, one of the founders of the environment NGO Flimkien Ghal Ambjent Ahjar, was awarded a trophy and was also invited to attend the grand final held at the European Parliament in Strasbourg on 5 December 2008, International Volunteer Day. Here, she will compete as Malta's nominee for the European Trophy of Voluntary Work, the winner of which will be announced by French President Nicolas Sarkozy. SOS Malta is currently producing a five-minute clip about her work to screen in Strasbourg as part of the selection process.

### Malta Resource Centre<sup>12</sup> invited CEO of Volunteer Centres Ireland to train health NGOs on Volunteer Management

On 30 October, representatives from 12 health NGOs attended a training seminar entitled '*Capacity Building through Volunteering*' at St James Cavalier, Valletta (Malta). The training was lead by Dr. Yvonne McKenna, CEO of [Volunteer Centres Ireland](#)<sup>13</sup>, and focused on the principles of volunteer management including the cycle linked to recruiting, screening, training and retaining volunteers. The overall aim of the seminar was to further equip health NGOs with the appropriate knowledge, skills and attitudes linked to managing and retaining volunteers, who are vital resources in these organisations.



On 31 October, the staff at Mater Dei Hospital (MDH) that currently have volunteers in their department and also those who are about to introduce volunteers into their departments, attended an interactive lecture entitled '*Making the most of Volunteer Resources in a Hospital Setting*' by Dr. Yvonne McKenna. #### Croatia



[Association for Civil Society Development SMART](#)<sup>17</sup> will organise the 2008 International Volunteer Day campaign - "Volunteer yourself" from 24 November to 5 December, under the auspices of City of Rijeka and Primorsko-Goranska County.

The objective of the campaign is to celebrate the International Volunteer Day and to increase visibility of volunteering in the City of Rijeka and Primorsko-goranska County. The campaign will incorporate a comprehensive set of activities through various events presented in the following calendar.

[Volunteer Centre Osijek](#)<sup>18</sup> operates in the Slavonija and Baranja region, where two main activities will take place. One will be the organisation of the "Opened doors day" where several CSOs and social and health care institutions will open their doors for one day for high school pupils and their teachers. The CSOs and other institutions will present their volunteer programmes to them and launch a common dialogue regarding the possibilities for youth volunteering within the community. The other activity is the Annual Volunteer Award Ceremony. Every year since 2006, Volunteer Centre Osijek organises this Ceremony as a way

to celebrate volunteers who help their community. Every year, six awards go to individuals who helped their community, to organisations who have developed innovative volunteer programs and for business sector for employee volunteering initiatives.

### Czech Republic

On the 4 December 2008, the [Volunteer Centre Ústí nad Labem](http://www.cev.be/9-members_dobrovolnické_centrum_dc_16-EN.html)<sup>19</sup> and a group of volunteers from SČVK (corporation operating on the half of the territory of Czech Republic in water consumption) will help handicapped people on the „Open door day“ and opening of the Advent ecological garden event. Under this employee-volunteering scheme, the volunteers will help handicapped people to move around the facility area and visit the Christmas workshops. On the International Volunteer Day, the volunteer centre will launch an information campaign and open nomination for the Volunteer Award 2008.

### Finland

On the 5 December, the [Citizen Forum](http://www.cev.be/9-members_kansalaisareena_(citizen_forum)_3-EN.html)<sup>20</sup> together with 3 other organisations (the Finnish Federation for Social Welfare and Health, the Finnish Youth Cooperation – Alliance, and the Finnish Sports Federation) will hold a celebration for volunteering in the national Parliament. In the event, speeches by prominent figures in the field of volunteering will be presented. The Finnish Federation for Social Welfare and Health will also reward someone for his or her merits in citizen activity. During the volunteering week, the Citizen Forum will also, together with several other NGOs, organise a “live library” in the Helsinki central station. The idea is to have “live books” which people can borrow for a short loan. Live books are volunteers, and any member of public may borrow a volunteer for a short chat, to have a coffee with or anything they would like to do in 15 minutes or so. “Live books” will discuss volunteering with people who borrow them.



Moreover, the Citizen Forum, together with other partners active in the field of volunteering are going to meet with 3 ministers (education, culture, social & health) – the idea behind this meeting is to hand out to the ministers the Manifesto for volunteering in Europe as well as 5 national thesis on volunteering which were created in cooperation with several organisations. In the beginning of the volunteering week, municipal council representatives of the 7 largest cities in Finland will receive by mail the above-mentioned Manifesto and Thesis. Municipal elections were held in October, and the Citizen Forum wants to remind the new representatives of the role of volunteering in our society.

### Germany



On the 5 December, the member centres of the [German Caritas Association of Volunteer Centers](http://www.cev.be/9-members_deutscher_caritasverband_verbund_freiwilligen_zentren_19-EN.html)<sup>21</sup> (Brandenburg, Geldern, Günzburg, Heinsberg, Innsbruck (Austria), Mönchengladbach, Rüsselsheim, Straubing, Stuttgart, Willich and Anklam) will contribute to the International Volunteers' Day 2008 – they will honour volunteers, give information of their work and open the doors of the centres to the public. They will present possibilities for volunteers in projects in the region and in the town and will held photo exhibitions. The centres will create open space for conversation around different topics of volunteering, give rewards to their volunteers and invite them to a party.

### Greece

The "Portrait of Volunteer" publication aims to illustrate the diversity of volunteers and the diversity of their activities, helping the various stakeholders to better understand who are the volunteers, what are the volunteers doing and what is the impact of their involvement. The second edition of the publication will be available in Romanian and English and will be widely distributed among volunteer involving organisations and stakeholders in the country.

## Slovakia



Four awarding ceremonies for volunteers are being organised at regional level, on the occasion of the International Day of Volunteers: in Bratislava on December 1 organised by [C.A.R.D.O.](#)<sup>27</sup>, in Banská Bystrica region organised by the Volunteer Centre on December 4 and in the Prešov region organised by SAIA Prešov. ## European Union News

### European Parliament launched its TV channel

[EuroparlTV](#)<sup>31</sup> was launched on the 17 September in order to "bring the Parliament closer to European citizens" and to combat the political disenchantment among citizens ahead of the European elections in June 2009.<sup>32</sup> The aim of the EP channel is to close the gap between EU institutions and the citizens, who often struggle with a feeling that EU institutions are too distant from them. ### Commission's consultations on the EU's youth policy, including volunteering – REMINDER!

As already mentioned in the previous edition of the CEV News, the European Commission has launched an online public consultation on how the EU's youth policy should develop in the future. This consultation will help the Commission to evaluate the achievements of European cooperation on youth policy since 2000, and it will lead the definition of fresh objectives for the next decade.

The consultation seeks to answer questions about the main challenges or opportunities, which will have the most direct impact on young people. The questionnaire covers issues regarding education and informal learning, employment, discrimination, social integration and voluntary activities of young people. The results of the consultation will be taken on board by the European policymakers in order to prepare concrete measures to help young people integrate into society, find work, improve their general well-being and get involved in society as citizens. The consultation is available until 25th of November in all EU languages and is addressed both to individuals and organisations on the Youth [website](#)<sup>34</sup>.

### New website reveals EU funding beneficiaries

On the 2 October 2008, the European Commission launched a website with the details of the beneficiaries of EU funding. The "Financial Transparency System" forms part of a wider transparency initiative launched by Administration and Anti-Fraud Commissioner Siim Kallas in

## Worst EU Lobbying Awards 2008

The general public is invited to vote for this year's '[worst EU lobbyists](#)'<sup>37</sup>. Under this event, the awards will be given to those lobby groups and EU officials that in 2008 engaged in "the most deceptive lobbying" and "the most-biased decision-making"<sup>38</sup>. The aim is to make public the non-official activities of lobbyists and their influence on European decision-making process. Voting will last until 30 November. The winners will be announced on 9 December at a ceremony in Brussels and then published online. Among different categories, this year a new one – "worst conflict of interest" – appeared. This category was introduced in order to "highlight the need for EU institutions to clean up their own activities" and introduce "stronger ethics rules".<sup>39</sup> To read more, click [here](#)<sup>40</sup>.

## 2009 – Year of the Western Balkans

On 5 November 2008, the European Commission adopted its annual strategy paper for the EU's enlargement policy. At the same time, the Commission reviews the progress achieved in the EU candidate countries of western Balkans and Turkey. The western Balkan region is approaching the EU membership with Croatia being the leader. In case it fulfils all necessary criteria, Croatia could become full EU member by the end of 2009. The remaining candidate countries (Turkey and FYR of Macedonia) as well as some of the potential candidate countries (Albania, Montenegro and Bosnia and Herzegovina) have made progress and are moving ahead, but further efforts are still needed. Serbia is slowly approaching the candidate status, which it could obtain by the end of 2009. For more information, click [here](#)<sup>41</sup>.

## Conference on corporate social responsibility organised by the European Commission and the European Economic and Social Committee

Conference on corporate social responsibility entitled "Partnership and transparency at the heart of European Corporate Social Responsibility", organised jointly by European Commission, European Economic and Social Committee and French Economic, Social and Environmental Council took place on 30 October 2008 in Paris.

Corporate social responsibility (CSR) was defined by the European Commission as a concept whereby "companies integrate social and environmental concerns in their business operations and in their interaction with their stakeholders on a voluntary basis".<sup>42</sup> The aim of this conference was to highlight the determining role of partnership and transparency for European added value with regard to CSR. They must also be active at a European level (have activities and members in at least three EU Member States). The funded actions must be carried out in one of the 27 Member States.
